Resolution of the Tribal Council Resolution Number 2013 – 04

WHEREAS, The Delaware Tribal Council is authorized by the Constitution and By-Laws of the Delaware Tribe to represent and act on all matters that concern the general welfare of the Tribe, and,

WHEREAS, the Delaware Tribal Council has established a tribal operations facility in Caney, Kansas at 601 High Street for the purpose of administering social services programs and to house offices for the Delaware Enterprise Authority, and

WHEREAS, The Delaware Tribal Council desires to place this property in federal trust status for the purpose of operating tribal programs on Delaware Indian trust land as a sovereign Indian tribal government,

NOW THEREFORE BE IT RESOLVED THAT, The Delaware Tribe of Indians hereby authorizes the transfer of property deed for the following tribal property at 601 High Street in Caney Kansas, the legal description of the parcel of interest is:

“Part Section of Southwest $\frac{1}{4}$ of Northeast $\frac{1}{4}$ of Northeast $\frac{1}{4}$ of Section 13, Township 35 South, Range 13 East, of the Sixth Principal Meridian, City of Caney, Montgomery County, Kansas and being more particularly described as follows:

Commencing at the Southwest Corner of the Northeast Quarter of the Northeast Quarter of Section 13, Township 35 South, Range 13 East of the Sixth Principal Meridian, City of Caney, Montgomery County, Kansas;
Thence N 1° 39' 13" W along the West Line of said Northeast Quarter of the Northeast Quarter, which is the Basis Of Bearings, a distance of 50.01 feet. to the North Line of the South 50 feet of said Northeast Quarter of the Northeast Quarter;
Thence N 89° 43' 59" E a distance of 30.01 feet, to the East Right Of Way Line of High Street, for the True Point Of Beginning;
Thence N 1° 39' 13" W along said East Right Of Way Line of High Street a distance of 228.03 feet, to the South Line of the North 50 feet of the South Half of the Southwest Quarter of the aforementioned Northeast Quarter of the Northeast Quarter of Section 13;

Thence N 89° 38' 54" E, parallel to the North Line of said South Half of the Southwest Quarter, a distance of 476.96 feet;
Thence S 1° 39' 13" E a distance of 228.73 feet to the aforementioned North Line of the South 50 feet of the Northeast Quarter of the Northeast Quarter; Thence S 89° 43' 59" W a distance of 476.98 feet to the Point Of Beginning. Encompassing 2.5 acres, more or less...

to the United states of America, Department of the Interior, by and through its agency the Bureau of Indian Affairs, for the purpose of placing into federal trust status.
