## A RESOLUTION OF THE TRIBAL COUNCIL OF THE DELAWARE TRIBE OF INDIANS TO REAFFIRM TRIBAL JURISDICTION IN KANSAS

Resolution No. 2013 - 43

**WHEREAS**, the Delaware Tribe of Indians is federally recognized by the Secretary of the United States Department of Interior, as evidenced by the Constitution adopted and ratified May 27, 2009; and

**WHEREAS**, the Delaware Tribal Council is authorized by the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

**WHEREAS**, the Tribe submitted an application for Land-in-Trust in Caney, KS located in Montgomery County on March 20, 2013, and

**WHEREAS**, a cloud on the title required a new survey, which resulted in a revised legal description of the property.

**NOW THEREFORE BE IT RESOLVED THAT**, the Delaware Tribal Council supports the submission of an amended Trust Application for the property in Caney, KS for the Delaware Tribe of Indians.
