



**A RESOLUTION OF THE TRIBAL COUNCIL OF THE
DELAWARE TRIBE OF INDIANS FOR THE TRANSFER
OF LAND INTO TRUST (WITHIN OUR LAST
RECOGNIZED RESERVATION BOUNDARY) IN
LEAVENWORTH, KANSAS**

RESOLUTION 2014-41

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and,

WHEREAS, the Delaware Tribal Council of the Delaware Tribe of Indians is initiating tribal operations at 1701 S. 4th Street, in Leavenworth, Kansas 66048 to establish a gaming operation facility.

WHEREAS, the Delaware Tribal Council wishes to place this property in the City of Leavenworth and within the last known reservation of the Delaware Tribe and place it into federal trust status under 25 USC § 2719(a)(2)(B) and 25 CFR § 292.4.

WHEREAS, the Delaware Tribe wishes to conduct gaming within the Tribally owned land in Leavenworth with the goal of promoting economic development for the Tribe, City of Leavenworth, County of Leavenworth, and State of Kansas.

NOW THEREFORE BE IT RESOLVED, the Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize the transfer of property deed for the following tribal property at 1701 S. 4th Street in Leavenworth, Kansas 66048; the legal description of the parcel of interest is:

“Commencing at the Northwest corner of the Northeast fractional Quarter of Section 1, Township 9, Range 22 East, Leavenworth County, Kansas; thence South along the East line of Fourth Street 889.30 feet; thence East parallel to the North line of said Section 1 535 feet to the West line of the Kansas City Northwestern Railroad Company’s right-of-way; thence Northeasterly along the West line of said right-of-way to the North line of said Section 1; thence West along the North section line of said Section 1 to the place of beginning, and being a part of what is known as “The Reagan Tract” on South Fourth Street in the City of Leavenworth, less any part taken or used for road.

AND:

All of lots 1, 2, 3, 4, 5 and 6, Block “H” for Fackler’s Addition, less ROW, in the City of Leavenworth, Leavenworth Co., Kansas.

to the United States of America, Department of the Interior, by and through its agency the Bureau of Indian Affairs, for the purpose of placing into federal trust status.
