#### Part I. Administrative

1. An extension was granted on July 2, 2004. The end date was extended by fourteen months from the original end date of June 30, 2004 to the new end date of August 31, 2005. No modifications were made to the scope of work or budget.

#### Part II. Project Description

- 1. The results of our NAGPRA funded work toward the repatriation of human remains and funerary objects from the State Museum of Pennsylvania include the following achievements.
  - A. Consultations were conducted with the Delaware Nation and the Stockbridge Munsee regarding the reburial of the human remains and funerary objects culturally affiliated with the Delaware Tribe and the Delaware Nation. Such consultations resulted in the drafting of a joint claim letter requesting the repatriation of Human Remains and Funerary Objects from the State Museum (attachment 1). Although the joint claim letter was drafted in consultation with representatives from the Delaware Nation and the Stockbridge Munsee, the letter was never signed by the Delaware Nation and Stockbridge Munsee representatives and thus not submitted to the State Museum of Pennsylvania.
  - B. Meetings were held with local, state and federal representatives to determine the suitable location for reburial. Two Delaware Tribal representatives consulted with the State Museum about the collection's readiness to be repatriated and discussed possible locations for the reburial in the state. With such suggestions, we created a map of all of the sites from which the Delaware human remains and funerary objects in the collection were excavated and presented the map and suggested reburial locations to the Delaware Tribe's Elders Committee and Cultural Preservation Committee. Following consultation with the Delaware Tribe's Elder's Committee and Cultural Preservation Committee, we contacted the Pennsylvania Historical and Museum Commission to request a reburial at Pennsbury Manor (attachment 2). We were given verbal approval and later consulted with the Director at Pennsbury Manor during a site visit in the Summer of 2005. We inspected and identified possible reburial locations and discussed the feasibility of a reburial. Though nothing formal was established, it was clear from our discussion with the Director that Pennsbury Manor would be willing to accommodate the reburial.
- 2. An unexpected and tragic event halted our repatriation efforts with the State Museum of Pennsylvania. On November 16, 2004, the United States Court of Appeals, Tenth Circuit judicially terminated the Delaware Tribe's federal acknowledgment (Attachment 3). With acknowledgment terminated, the Delaware Tribe could no longer repatriate the collection at the State Museum of Pennsylvania under the NAGPRA provisions. Although this decision limited our eligibility under NAGPRA, we continued to work toward the repatriation and reburial as witnessed by our consultation at Pennsbury Manor in 2005. However, without federal acknowledgment, the Delaware Tribe could not legally be the entity that submitted the repatriation claim and thus our project was suddenly reliant on the other two participating tribes who had yet to sign the already drafted joint claim letter. The Delaware Nation and the

Stockbridge Munsee not only had their own ongoing NAGPRA related projects but were also reluctant to continue work on a project that was instigated by a tribe that was stripped of federal acknowledgment. As a result, two planned results were unable to be accomplished. They include the following changes.

- A. We did not arrange for the construction of an appropriate burial container for the human remains and funerary objects because we were never able to repatriate the collection without federal acknowledgment, and/or without the support from the other participating tribes.
- B. We did not arrange for 6 authorized tribal representatives to travel to the State Museum of Pennsylvania in order to complete the repatriation and reburial of the human remains and funerary objects at the museum. Without federal acknowledgment, we lacked standing to repatriate under NAGPRA and the other participating tribes were unable to do so as well. Thus, the remains continue in the possession and control of the State Museum of Pennsylvania where they will likely remain until the Delaware Tribe is restored federal acknowledgment and can carry out this important repatriation and reburial.
- 3. The key partners and participants include the State Museum of Pennsylvania, Delaware Nation, Stockbridge Munsee Band of Mahican Indians and Pennsbury Manor.
- 4. The impact of the project was difficult to assess because the proposed repatriation and reburial was never able to be completed. One clear impact was that the consultations with the Delaware Elder's Committee and Cultural Preservation Committee brought a greater awareness to our tribal members about the former locations of Delaware burial sites in Pennsylvania and the extent of the number of human remains and funerary objects held in museum. Our consultations also affirmed the generally held feeling among tribal elders that excavated burials should be reburied in as close a proximity to the original internment site as possible. It is not appropriate to repatriate the remains to tribal lands in Oklahoma for reburial unless the remains were originally interred in Oklahoma. Another impact was that a potentially important relationship between the Delaware Tribe and the Pennsbury Manor was established through our consultations. The staff at the Pennsbury Manor were very much in support of a reburial at the Manor and we found the location to be an excellent place for the deposition of the collection at the State Museum of Pennsylvania as well as for other human remains and funerary objects that were excavated from sites in the vicinity of the Delaware River Valley.
- 5. When federal acknowledgment is restored, we intend to re-apply for NAGPRA funding in order to allow us to complete the repatriation of the Delaware human remains and funerary objects at the State Museum of Pennsylvania and rebury the remains on a 10 X 10 plot in the grounds at Pennsbury Manor.

- 2. Differences did exist between the budget and the actual work-costs. Each line item is explained below.
  - A. Salaries and Wages: More money was used to support the costs of salaries for the NAGPRA staff because more than expected work was required. We did not anticipate that it would take as much effort as it did to locate an appropriate reburial location and to gain the approval and cooperation from the other participating tribes.
  - B. Fringe Benefits: More money was used to support the costs of Fringe Benefits for the NAGPRA staff because more than expected work was required. We did not anticipate that it would take as much effort as it did to locate an appropriate reburial location and to gain the approval and cooperation from the other participating tribes.
  - C. Travel and Per Diem: Far less money was used to support the travel and per diem costs because we were able to use other funding sources for most of our staff's consultations with the State Museum of Pennsylvania, Pennsbury Manor and with the other participating tribes. We also made a conscious effort to save as much travel and per diem money as possible in order to be able to adequately provide for the 6 member tribal delegation to attend the reburial. Since the reburial has yet to take place, the funds reserved for travel and per diem to the reburial has remained unspent.
  - D. Supplies and Materials: In our original budget, we asked for and received funding to purchase a printer for the NAGPRA office. In the meantime, we were able to use other funding sources to purchase the printer and thus used the NAGPRA funding to purchase less expensive, although necessary, supplies. We also made a conscious effort to save as much funding as possible in order to be able to adequately provide for the 6 member tribal delegation to attend the reburial.
  - E. Services: No funding was used to provide for the requested services. We originally asked for and received funding to provide for the anticipated costs of duplication and printing, long distance phone calls, postage and for a car rental to use during the reburial. We were able to utilize other funding sources to pay for the duplication and printing, long distance phone calls and postage and thus no NAGPRA funds were drawn. Also, since the reburial has yet to take place, the funds reserved for a rental car for our use during the reburial has remained unspent.
  - F. Other Costs: No funding was used to provide for the requested other costs. We originally asked for and received funding to compensate the grant writer with a grant writing stipend and to purchase a burial container for the reburial as well as provide for the burial container's transportation to the burial site. Although the grant writer was paid the stipend, the payment was coded under salaries and wages and thus does not appear

under this line item. Also, since the reburial has yet to take place, the funds reserved for a burial container and transportation to the reburial have remained unspent.

- G. Indirect Costs: Less money than expected was drawn down for indirect costs. The anticipated indirect costs were never drawn down because the tribe lost federal acknowledgment and was unable to complete the project.


