The Delaware Tribe seeks federal funding to carry out consultations and research that will lead to the comprehensive listing of all of the Notice of Inventory Completions for all of the human remains and funerary objects from two significant Delaware burial sites; the Abbott Farm Complex and the Chambers Site. With support from a FY 2010 Documentation Grant, we consulted with the Peabody Museum of Archaeology and Ethnology on their Abbott Farm collection and with the State Museum of Pennsylvania on their Chambers Site collection. During these consultations we learned that at least four other museums also hold collections from the Abbott Farm Complex and the Chambers Site. However, we have not had an opportunity to consult with the four additional museums and each museum is at different stages in their documentation process.

The Delaware Tribe requests NAGPRA funding that will allow us to consult with the New Jersey State Museum, the Field Museum of Natural History and the American Museum of Natural History on their collections from the Abbott Farm Complex and with the Carnegie Museum of Natural History on their collection from the Chambers Site. While we will also consult with each museum on their other collections, our grant supported consultations will focus on work that will lead to a NAGPRA inventory for the Chambers Site, a cultural affiliation study for both sites and the publication of four Notices of Inventory Completion; one from each of the additional museums. We will also document the treatment histories of the collections in preparation for a repatriation of both sites.

SECTION 2. PROJECT DESCRIPTION

A. GRANT OBJECTIVES AND ACTIVITIES.

Goal 1: Facilitate the publication of a Notice of Inventory Completion for their Chambers Site collection at the Carnegie Museum of Natural History.

The Chambers site (36Lr11) is a historic Delaware village once known as Kuskuskie's Village (AD 1763-1776) in what is today western Pennsylvania. During consultations with the State Museum of Pennsylvania, we learned that there were a total of 79 burials excavated from the site and that the State Museum of Pennsylvania is not in possession of much of the collection. The State Museum of Pennsylvania holds only 8 Individuals and 2,116 AFOs from the Chamber's Site; all of which have been culturally affiliated with the Delaware Tribe in a published Notice of Inventory Completion. Although consultations did take place, no cultural affiliation study was performed to make this determination.

Our subsequent research found that the Carnegie Museum of Natural History holds another 48 MNI and 3,012 AFO's from the Chambers Site. We have yet been unable to locate the remaining 23 individuals and are uncertain if there are other funerary objects in other museums. The Carnegie Museum of Natural History has not completed a NAGPRA inventory for their Chambers Collection. We have initiated consultation with the Carnegie Museum of Natural History who has indicated that they agree that the Chambers Site is affiliated with the Delaware. However, no cultural affiliation study has been performed to make this determination.

Objective 1: Carry out consultations and research that will lead to a NAGPRA inventory and a consistent determination of cultural affiliation for the Chambers Site.

Activity: The Project Director and the Project Assistant will travel to, and consult with, the Carnegie Museum of Natural History on their Chambers site collections and other potentially Delaware affiliated collections.

Activity: During our consultations, we will provide a copy of our report, "Traditional Delaware Funerals," completed with support from a FY 2010 Documentation Grant, to assist the museum staff in their identification of Delaware funerary objects.

Activity: The Project Assistant will consult with, and assist, the Carnegie Museum and Ft. Ligonier while they each complete an inventory of their Chambers site collections.

Activity: The Project Director and Project Assistant will carry out background research in preparation for a Delaware Cultural Affiliation Study of the Chamber Site. The Cultural Affiliation Study will be based on evidence relevant to the ten lines of evidence (geographical, kinship, biological, archaeological, anthropological, linguistic, folkloric, oral tradition, historical and other relevant information) to make a determination of cultural affiliation for the entire site (thus encompassing the collections from all three museums) as required by NAGPRA.

Activity: The Project Director and Project Assistant will consult with the Delaware Cultural Preservation Committee while writing a Cultural Affiliation Study of the Chambers Site.

Activity: The Project Director and Project Assistant will consult with the Carnegie Museum of Natural History while they draft a Notice of Inventory Completion for Chambers site collections.

Deliverable: A Report on the Delaware Tribe's consultation with the Carnegie Museum of Natural History.

Deliverable: The NAGPRA Inventory for the Chambers site collection at the Carnegie Museum of Natural History.

Deliverable: A copy of the Delaware Tribe's Cultural Affiliation Study of the Chambers site.

Deliverable: A Report on the Carnegie Museum of Natural History's progress in drafting a Notice of Inventory Completion for their Chambers site collection.

Goal 2: Facilitate the publication of New Jersey State Museum, Field Museum of Natural History and the American Museum of Natural History's Notices of Inventory Completion for their collections from the Abbott Farm Complex.

The Abbott Farm Complex represents a continuous chain of prehistoric and proto-historic villages which occupied the eastern bluff rim along the lower Delaware River. Over 100 individuals have been excavated from the Abbott Farm complex over the past century and we were able to locate at least 109 of these individuals along with 94 identified funerary objects that are now curated in at least four museums. Two of the museums have determined their Abbott Farm collections as affiliated with the Delaware Tribe and two others have determined their Abbott Farm collections as culturally unidentifiable.

Our consultations with the Peabody Museum of Archaeology and Ethnology confirmed that the Peabody holds 15 individuals and 50 Funerary Objects from the Abbott Farm Complex and this collection has been published in the Federal Register as culturally affiliated with the Delaware Tribe. Although consultations did take place, no cultural affiliation study was performed to make this determination.

The New Jersey State Museum holds 34 individuals and 0 Funerary Objects from the Abbott Farm complex that have been affiliated with the Delaware Tribe and the inventory was last updated in 2011, but the Notice of Inventory Completion has yet to be published in the Federal Register. With support from a 2004 Documentation grant, our office did consult with the New Jersey State Museum in 2005, but no cultural affiliation study was performed to make this determination.

The Field Museum of Natural History holds 17 Individuals and 26 Funerary Objects from the Abbott Farm complex that have been affiliated as culturally unidentifiable. Their inventory was completed and was last updated in 2010 but the Notice of Inventory Completion for this collection has yet to be published in the Federal Register. We have no record of consultation during their documentation process and no cultural affiliation study was performed to make their determination.

The American Museum of Natural History holds 43 MNI and 18 Funerary Objects from the Abbott Farm Complex that have been affiliated as culturally unidentifiable. Their inventory was completed and was last updated in 2004 but the Notice of Inventory Completion has yet to be published in the Federal Register. We have no record of consultation during their documentation process and no cultural affiliation study was performed to make their determination.

With conflicting determinations of cultural affiliation for collections excavated from the same site and without consultation; we feel there is a critical need to carry out consultations and research with each museum.

Objective 2: Carry out consultations and research that will lead to a consistent determination of cultural affiliation for all of the identified collections excavated from the Abbott Farm Complex.

Activity: The Project Director and the Project Assistant will travel to, and consult with the New Jersey State Museum, the Field Museum of Natural History and the American Museum of Natural History on their Abbott Farm Collections and other potentially affiliated collections.

Activity: During our consultations, we will provide a copy of our report, "Traditional Delaware Funerals," completed with support from a FY 2010 Documentation Grant, to assist the museum staff in their identification of Delaware funerary objects.

Activity: The Project Director and the Project Assistant will carry out background research in preparation for a Delaware Cultural Affiliation Study of the Abbott Farm Complex. The Cultural Affiliation Study will be based on evidence relevant to the ten lines of evidence (geographical, kinship, biological, archaeological, anthropological, linguistic, folkloric, oral tradition, historical and other relevant information) to make a determination of cultural affiliation for the entire site (thus encompassing the collections from all four museums) as required by NAGPRA.

Activity: The Project Director and Project Assistant will consult with the Delaware Cultural Preservation Committee while writing a Cultural Affiliation Study of the Abbott Farm Complex.

Activity: The Project Director and Project Assistant will consult with the New Jersey State Museum, the Field Museum of Natural History and the American Museum of Natural History while they each draft a Notice of Inventory Completion for their Abbott Farm collections.

Deliverable: A Report on the Delaware Tribe's consultation with the New Jersey State Museum, the Field Museum of Natural History and the American Museum of Natural History

Deliverable: A copy of the Delaware Tribe's Cultural Affiliation Study of the Abbott Farm Complex.

Deliverable: A Report on the progress at each museum in drafting a Notice of Inventory Completion for the Abbott Farm collections.

Goal 3: Determine if it will be necessary to test the Abbott Farm Complex and Chambers Site collections before we expose tribal members to the collections during an eventual repatriation.

Objective 3: Document the treatment histories of Abbott Farm and Chambers Site collections

Activity: In order to ensure a safe repatriation, project staff will visit the collections to carry out on-site research of the collection's treatment history.

Activity: After returning from the museums, the Project Assistant will draft a report in consultation with the Project Director on the treatment histories of each of collection.

Deliverable: A report on the treatment histories of the Delaware collections at the collaborating museums that determines if there is a need to decontaminate the remains before repatriation.

B. PARTNERSHIPS AND RESULTS.

New Jersey State Museum: The New Jersey State Museum will consult with us concerning their collection from the Abbot Farm Complex and other Delaware affiliated collections. They are prepared to meet with us to consult on the treatment history of their collections, receive a copy of our report, "Traditional Delaware Funerals," and provide us access to their accession records and other relevant documents so that we will be able to produce a cultural affiliation study. The New Jersey State Museum will also submit a Notice of Inventory Completion following our consultations and research.

Field Museum of Natural History: The Field Museum of Natural History will consult with us concerning their collection from the Abbot Farm Complex and other Delaware affiliated collections. They are prepared to meet with us to consult on the treatment history of their collections, receive a copy of our report, "Traditional Delaware Funerals," and provide us access to their accession records and other relevant documents so that we will be able to produce a cultural affiliation study. The Field Museum of Natural history is prepared to submit a revised Notice of Inventory Completion following our consultations and research if such action is deemed necessary.

American Museum of Natural History: The American Museum of Natural History will consult with us concerning their collection from the Abbott Farm Complex and other Delaware affiliated collections. They are prepared to meet with us to consult on the treatment history of their collections, receive a copy of our report, "Traditional Delaware Funerals," and provide us access to their accession records and other relevant documents so that we will be able to produce a cultural affiliation study. The American Museum of Natural History is prepared to submit a revised Notice of Inventory Completion following our consultations and research if such action is deemed necessary.

Carnegie Museum of Natural History: The Carnegie Museum of Natural History will consult with us concerning their collection from the Chambers Site and other Delaware affiliated collections. They are prepared to meet with us to consult on the treatment history of their collections, receive a copy of our report, "Traditional Delaware Funerals," and provide us access to their accession records and other relevant documents so that we will be able to locate affiliated collections in other museums. The Carnegie Museum of Natural History is prepared to submit a NAGPRA Inventory and a Notice of Inventory Completion for their Chambers site collection following our consultations and research.

Strategic Plan/Capacity: The Delaware Tribe's NAGPRA Program is housed as a part of the Delaware Tribe's Historic Preservation Office (DTHPO) with the DTHPO staff each committing a portion of our time to complete NAGPRA related projects. The mission of the Delaware Tribe's NAGPRA Program has been to identify museums and federal agencies in control of ancestral Delaware human remains and funerary objects, assist museums through consultation and research with the determination of cultural affiliation for such remains and actively pursue the safe repatriation and secure reburial of culturally affiliated remains. Federal funding

will allow our office to complete the documentation of two significant Delaware burial sites that will lead to the safe repatriation located with six museums.

Monitoring/Evaluation: The assessment of the project activities will be carried out by the Project Director who is also the Director of the Delaware Tribe's Historic Preservation Office and reports to the Delaware Tribe's Business Manager who will have the ultimate oversight to ensure compliance with federal and tribal regulations. The Project Director will submit monthly reports to the Business Manager and the Delaware Tribal Council that will describe each month's activities and their alignment with the project activities listed in the timeline for this proposal. The Delaware Tribe's accounting department will also submit monthly financial statements to the Project Director, the Business Manager and the Delaware Tribal Council to ensure that expenditures are consistent with the grant activities listed in this proposal.

C. PERSONNEL QUALIFICATIONS.

Brice Obermeyer, Project Director: The Project Director will dedicate the equivalent of 10 hours/week (.25FTE) to monitor the grant funded objectives and activities. The Project Director will draft and finalize all reports that will serve as the deliverables for this grant while also remaining in contact with each museum as they complete or consider revising their NAGPRA inventories and draft or consider revising their Notice of Inventory Completions. The Project Director will also be the principle investigator to research and write the Cultural Affiliation Studies of the Chamber Site and Abbott Farm Complex. Dr. Obermeyer holds a Ph.D. in anthropology with over ten years of experience in Delaware ethnography, archaeology, tribal historic preservation and NAGPRA related issues (see attached resume). Such qualifications provide Obermeyer with the ability to consult with collaborating museums on the revisions needed in order to publish four revised Notices of Inventory Completions as well as produce a Cultural Affiliation Study for the Abbott Farm Complex and Chamber Site.

Greg Brown, Project Assistant: The Project Assistant will dedicate the equivalent of 30 hours/week (.75FTE) to carry out the grant activities under the oversight of the Project Director. The Project Assistant will research and help draft all reports that will serve as the deliverables for this grant while also remaining in contact with each museum as they complete or consider revising their NAGPRA inventories and draft or consider revising their Notice of Inventory Completions. The Project Assistant will also assist the Carnegie Museum of Natural History as they finalize their NAGPRA inventory for their Chambers Site collection. The Project Assistant will also assist with the research and writing of the Cultural Affiliation Studies of the Chamber Site and Abbott Farm Complex. Greg Brown holds a M.A. in Archaeology with a specialty in Zooarchaeology and over twenty years of experience in colonial period archaeology. He has worked in the Delaware Tribe's Historic Preservation Office since 2009 where he has gained training and research experience in tribal historic preservation, NAGPRA and Delaware archaeology (See attached resume). Such qualifications provide Brown with the ability to help complete a NAGPRA inventory and provide support to our collaborating museums while they carry out the work needed in order to publish four revised Notices of Inventory Completions. His qualifications will also facilitate the research needed for a Cultural Affiliation Study for the Abbott Farm Complex and Chamber Site.

D. SCHEDULE OF COMPLETION

Objective 1: Beginning in September 2012, we will carry out consultations and research with the Carnegie Museum of Natural History that will lead to a determination of cultural affiliation for the Chambers Site.

Activity: In September and October 2012, the Project Director and the Project Assistant will travel to, and consult with the Carnegie Museum of Natural History on their Chambers site collection and other potentially Delaware affiliated collections. Based on our previous experiences, we anticipate that these consultations will

require 5 days in order to view and photograph the collection and ensure that the existing inventory is consistent with the physical collection holding. All consultations will be completed by November 1, 2012.

Activity: During our consultations in September and October 2012, we will provide and review with the staff at the Carnegie Museum our report, "Traditional Delaware Funerals."

Activity: During our consultations in September and October 2012, the Project Assistant will consult with, and assist, the Carnegie Museum while they complete a NAGPRA inventory of their Chambers site collection. We anticipate that the assistance with the inventory will require up to 15 days. All inventory assistance will be completed by November 1, 2012.

Activity: Beginning in November 2012, the Project Director and the Project Assistant will conduct research for a Cultural Affiliation Study of the Chambers Site. All research will be completed by February 1, 2013.

Activity: Beginning in February 2013, the Project Director and Project Assistant will consult with the Delaware Cultural Preservation Committee while drafting the Cultural Affiliation Study of the Chambers Site. The Cultural Affiliation Study will be completed by May 1, 2013 and shared with the Carnegie Museum.

Activity: Beginning in May 2013, the Project Director and Project Assistant will consult with the Carnegie Museum while they draft a Notice of Inventory Completion for the Chambers site collection. The Notice of Inventory Completion for the Chambers Site will be completed by September 1, 2013.

Objective 2: Beginning in February 2013, we will carry out consultations and research that will lead to a determination of cultural affiliation for all of the the Abbott Farm Complex.

Activity: Beginning in February 2013, the Project Assistant and Research Assistant will travel to, and consult with the Field Museum of Natural History, the New Jersey State Museum and the American Museum of Natural History on their Abbott Farm Collections and other potentially Delaware affiliated collections. Based on our previous experiences, we anticipate that each consultation will require 5 days at each museum in order to view and photograph the collection and ensure that the NAGPRA inventory is consistent with the physical collection holding. As the Field Museum of Natural History, the New Jersey State Museum and the American Museum of Natural History have all completed their inventories, it will not be necessary to assist each museum with completing their inventories. All consultations will be completed by May 1, 2013.

Activity: During our consultations with each museum from February to May 2013, we will provide and review with the museum staff a copy of our report, "Traditional Delaware Funerals."

Activity: Beginning in May 2013, the Project Director and Project Assistant will carry out research for a Cultural Affiliation Study of the Abbott Farm Complex. All research will be completed by February 1, 2014.

Activity: Following our consultation visits that will conclude by May 1, 2013, the Project Director and Project Assistant will continue to consult with the New Jersey State Museum, the Field Museum and the American Museum of Natural History throughout the remainder of the grant period while each museum considers revisions to their NAGPRA inventories.

Activity: Beginning in September 2013, the Project Director and Project Assistant will consult with the Delaware Cultural Preservation Committee while drafting a Cultural Affiliation Study of the Abbott Farm Complex. The Cultural Affiliation Study will be finalized by February 1, 2014 and shared with the New Jersey State Museum, the Field Museum and American Museum of Natural History.

Activity: Beginning in February 2014, the Project Director and Project Assistant will consult with the New Jersey State Museum, Field Museum of Natural History and the American Museum of Natural History while they each draft a Notice of Inventory Completion for their Abbott Farm collections. The three Notices of Inventory Completion for the Abbott Farm collections will be completed by June 1, 2014.

Objective 3: During our consultation we will document the treatment history of the collections at each museum.

Activity: During our consultations in September and October 2012, the Project Director and Project Assistant will also consult with the Carnegie Museum of Natural History to discuss what is known about the treatment history of their collection. The Project Assistant will photocopy the documents that are relevant to the treatment histories of the collection. All relevant documents will be reviewed and photocopied by November 1, 2012.

Activity: During our consultations from February to May 2013, the Project Director and Project Assistant will also consult with the New Jersey State Museum, the Field Museum of Natural History and the American Museum of Natural History to discuss what is known about the treatment history of their collections. The Project Assistant will photocopy the documents that are relevant to the treatment histories of the collection. All relevant documents will be reviewed and photocopied by May 1, 2013.

Activity: Beginning in February 2014, the Project Assistant will draft a report in consultation with the Project Director and museum representatives on the treatment histories of each collection. The report will be finalized by May 1, 2014 and a copy will be shared with each museum.

Salaries and Wages: In order to carry out the project activities in support of the proposed objectives, the Delaware Tribe's Historic Preservation Director will need to take on the responsibilities of serving as the Project Director. The Director is currently a part-time employee (.5 FTE) with an annual salary of \$25,000. The Project Director will commit an additional ten hours per week to carry out the NAGPRA funded project activities thus making the Director a $\frac{3}{4}$ time (.75 FTE) employee. The additional time committed to the grant funded project activities will be compensated at the rate of the Director's current salary thus requiring 18,749.97 over the course of 18 month period. The Delaware Tribal Historic Preservation Office will provide the matching funds so that the Project Director can continue to work on grant supported activities for the final 6 months of the 24 month grant period.

In order to carry out the project activities, the Project Assistant will work $\frac{3}{4}$ time (.75 FTE) on completing the project activities over the course of the 24 month grant period. The Project Assistant salary will be \$38,249.95 over the course of the grant period. The Delaware Tribal Historic Preservation Office will provide the matching funds so that the Project Assistant can continue to work on grant supported activities for the final 6 months of the 24 month grant period.

Fringe Benefits: 13.69% is a combination of the fringe benefits for which the Delaware Tribe is responsible for every employee. 7.65% is the salary percentage paid for social security and medicare (FICA), 5.5% is the salary percentage paid to Oklahoma state unemployment and .54% is the salary percentage paid to workers compensation. The Delaware Tribe only provides Health Insurance and Retirement benefits for full-time employees. Grant funding is requested for 18 months while the Delaware Tribe's Historic Preservation Office will provide matching funds to cover the fringe benefits for the final 6 months of the 24 month grant period.

Consultant Fees: N/A

Travel and Per Diem: In order to complete Objective 1 and 3, the Project Director and Project Assistant will drive from Bartlesville, Oklahoma to Pittsburgh, Pennsylvania over the course of five days to consult with the Carnegie Museum of Natural History. After 5 days of consultation, the Project Director will fly from Pittsburgh, Pennsylvania to Emporia, KS while the Project Assistant will remain in Pittsburgh, Pennsylvania to assist the Carnegie Museum of Natural History in completing their NAGPRA inventory for the Chambers Site over the course of 15 additional research days. After the inventory is complete, the Project Assistant will drive from Pittsburgh, Pennsylvania to Bartlesville, Oklahoma.

In order to complete Objective 2 and 3, the Project Director and the Project Assistant will drive from Bartlesville, Oklahoma to Chicago, Illinois to consult with the Field Museum of Natural History over the course of 5 days. The Project Director and the Project Assistant will also drive from Bartlesville, Oklahoma to New York, New York and stay 5 days to consult with the American Museum of Natural History. The Project Director and the Project Assistant will also drive from Bartlesville, Oklahoma to Trenton, New Jersey and stay 5 days to consult with the New Jersey State Museum.

Although it is a considerable distance to drive from Bartlesville, Oklahoma to the Carnegie Museum of Natural History, the Field Museum of Natural History, the American Museum of Natural History and the New Jersey State Museum, our experiences carrying out similar consultations with other museums has shown us that we will need to have our own vehicle in order to satisfactorily carry out the grant objectives. Our consultations will include collecting a substantial amount of paperwork on the history and treatment history of the collections and the cultural affiliation of the collection. Such research will result in the collection of boxes of files, documents and publications that will be easier to transport back to our office if we have our own vehicle as opposed to shipping the material by mail or loading it as "carry on" luggage for a return flight. Additionally, it is our ideal protocol to have two representatives from the Delaware Cultural Preservation Committee to join us during our consultations. Since our vehicle can seat four passengers comfortably, using our vehicle would allow us to accommodate two additional tribal representatives without increasing the travel costs for each consultation. Finally, using our vehicle makes it unnecessary to rent a vehicle to use for travel during the consultations thus further decreasing the overall travel expense.

Supplies and Materials: In order to complete the objectives, we will need a laptop computer, paper, printer, printer toner and a cell phone in order to document our consultations, assist with the inventories, complete the treatment history reports and draft the Cultural Affiliation Studies. The Delaware Tribe will provide the laptop computer, printer, paper and printer toner that will be needed to produce the necessary documents. We expect that such paperwork will require the use of one printer, 2 boxes of paper and one printer toner for ink. The Delaware Tribe will also provide the cell phone that the Project Director and Project Assistant will use to remain in contact with our collaborating museums throughout the duration of the grant project.

Other Costs: In order to complete Objectives 1 and 2, we will use NAGPRA funds to provide the Delaware Cultural Preservation Committee with a \$200/month stipend for providing information and feedback that will be necessary to complete the Cultural Affiliation Studies of the Abbott Farm Complex and the Chambers site. We will collaborate with the Delaware Cultural Preservation Committee over the course of 9 months. NAGPRA funds will also be used to compensate the grant writer for the time committed to preparing the grant. The Delaware Tribe will provide the funding that may be necessary to photocopy the accession records and relevant documents that will be needed to complete Objectives 1,2 and 3. The Delaware Tribe will also pay for the monthly cell phone service that will allow the Project Director and Project Assistant to remain in contact with our collaborating museums throughout the duration of the grant project.

Indirect Costs: Our most recent Indirect Cost Agreement was completed in 2010 and is 15.76% for non BIA programs. We have applied this Indirect Cost Rate to our current request. The 15.76% was applied to all funding requests in sections A – F, however, we excluded assessing indirect costs for the stipends to the Delaware Cultural Preservation Committee and the grant writing stipend (a total of \$2800). Thus, the Indirect

Cost Rate of 15.76% was only applied to a total of \$74943 and gives an Indirect Cost Rate charged to this grant of \$11,811.

FY 2010 Documentation Grant: 40-10-GP-524

Since receiving notification of our FY 2010 NAGPRA Documentation Grant in June 2010, we have been working with the Delaware Elders Committee, the Peabody Museum of Archaeology and Ethnology, the State Museum of Pennsylvania and the New York University College of Dentistry support our claims to items not listed in the Notices of Inventory Completion, publish revised Notices of Inventory Completion, document the treatment history of affiliated collections and reunite affiliated collections that are in the possession of other museums. A more detailed description of our progress is provided in the paragraphs below.

Objective A: Existing Database of Museum Inventories: We hired a project assistant, Gregory Brown, who began working on the grant-related work in October 2010. With his assistance, we have completed our digital database of museum inventories. Our original database of museum inventories has been updated from its 2004 version. Greg Brown has now completed the Delaware Tribe's NAGPRA database, which contains over 14,600 individual records from over 1000 archaeological sites that are located in more than 63 museums and institutions. The items in the database are also linked to over 400 scanned and digitized site forms, inventories, and correspondence related to each individual record.

Objective B: Attend the NAGPRA trainings and NAGPRA at 20 Symposium: NPI hosted **Basic NAGPRA seminar, Oct. 4-7, 2010:** Project Assistant, Gregory Brown attended the Basic NAGPRA seminar held in Phoenix, Arizona. Project Director, Brice Obermeyer and Project Assistant, Greg Brown attended the **NAGPRA at 20 Symposium** in Washington, D.C. Project Director, Brice Obermeyer attended the **NAGPRA seminars** in San Diego, CA. The report on our experiences and the impact on our program has been drafted.

Objective C: Publication of Revised Notices of Inventory Completion: We continue our consultation on revising the Notices of Inventory Completion at the three collaborating museums. All three museums have agreed to change the cultural affiliation language from "Delaware Tribe on behalf of the Cherokee Nation," to "Delaware Tribe". The Peabody Museum of Archaeology and Ethnology has provided verbal affirmation that they intend to make the corrections, however they are awaiting our consultation with other museums that hold collections from the Abbott Farm Complex before they submit their revised notices. The State Museum of Pennsylvania is drafting a revised Notice of Inventory Completion for for three sites (based on our grant supported research) but is awaiting our further consultation with the Carnegie Museum before they submit a revised notice for the Chambers Site. The New York College of Dentistry has submitted their corrected Notice of Inventory Completion which has not yet been published.

Objective D: Delaware Burial Practices in the Archaeological Record (re-titled as Traditional Delaware Funerals): An Ethnographic Approach for Documenting Funerary Objects under NAGPRA: We have completed and transcribed 10 interviews with tribal elders on traditional Delaware burial practices and have compiled a report that identifies those items that would have intentionally been left as funerary objects during the traditional ceremony. As the primary product of our Documentation Grant, a final draft of this report has been submitted for tribal approval. Following approval, a copy of the report will be shared with the collaborating museums to support our potential claims to items not listed in the Notices of Inventory Completion.

Objective E: Reunite items from the collections at our collaborating museums that are in the possession of other museums: We have carried out a considerable amount of research toward reuniting the collections at our collaborating museums. Following our consultations, we determined that an online database for each of the sites in the collections at the collaborating museums would provide the best way to reunite the collections from other museums that hold items from the same sites. A copy of the cover page for the online database can be viewed at the following web address <http://delawaretribe.org/culturesite/delaware-tribe-historic-preservation-office/>. This site is periodically updated as new information comes to light. Access to the site is password protected but a password will be provided upon request to our office.

Objective F: Document the Treatment Histories of the collections at the collaborating museums: A draft report on the treatment histories of the collections at the collaborating museums has been completed and is being sent to each museum for their review. Once reviewed by each museum, we will finalize the report.
