APPOINTEE QUESTIONNAIRE AND VERIFICATION HISTORIC PRESERVATION STEERING COMMITTEE

The Delaware Tribe of Indians Constitution and Bylaws at Article V, Section M. charges the Delaware Tribal Council to appoint subordinate committees, commissions, boards, tribal officials and employees not otherwise provided for in this Constitution and Bylaws and to prescribe their duties, salaries, and tenure.

Pursuant to the guidelines and requirements of the funding agency for the Historic Preservation
Department a steering committee is to be established to assist and guide the department. The Tribal
Council is currently seeking individuals interested in serving as members of the Historic Preservation
Steering Committee and will be approved in the form of a Tribal Resolution adopted by a majority vote of
the Tribal Council at a regularly scheduled meeting. The Delaware Tribal Council further requires those
appointed to this committee, be knowledgeable of Lenape culture.

The Delaware Tribe of Indians is in search of volunteers to serve on the Historic Preservation Steering Committee. This committee would help provide a sharper direction for the Historic Preservation Department including addressing preservation questions; aid in developing programs and identifying opportunities for the department and community.

Meetings will be held twice monthly. One at the Bartlesville campus and secondly via Teams or in person with the Historic Preservation Department. There will be an hourly stipend not to exceed \$200 per month per committee member.

The purpose of this questionnaire is to advise the appointees of qualifications and responsibilities of service, and for the appointee to educate the members of the Council regarding their backgrounds, qualifications, goals of service and recognition of commitment. Please complete the questionnaire, verify that you have read the tribe's governing documents associated with the entity you have been appointed to, provided they have been approved by the Tribal Council, verify you meet the requirements and agree to abide by the laws and other governing documents controlling your service, and that you are not disqualified under any Ethics Code or the law authorizing the entity to which you are appointed.
