A Resolution of the Delaware Tribe of Indians Approving Tribal Membership in NCAI for the Year 2013-14 Resolution No. 2013 – 34

WHEREAS, the Delaware Tribe of Indians wishes to become a Member Indian/Native Government in Good Standing with the National Congress of American Indians (NCAI); and,

WHEREAS, the Delaware Tribe of Indians meets all requirements for Tribal Membership, pursuant to Article III - Members, Section B of the Constitution and By-Laws of NCAI.

NOW, THEREFORE BE IT RESOLVED that the Delaware Tribal Council, which is the official governing body of the Delaware Tribe of Indians, hereby authorizes Paula Pechonick who is the official principal tribal official, to take the necessary action to place the Delaware Tribe in Membership with NCAI; and,

BE IT FURTHER RESOLVED that Tribal funds in the amount of \$ 110.00, based on the Tribal Membership dues schedule in the NCAI By-Laws, Article III - Members, Section C 2 are authorized to be paid for NCAI membership; and,

BE IT FURTHER RESOLVED that based on the tribal enrollment of 10,732 persons, the Delaware Tribe shall have 180 votes, in accordance with Article III - Members, Section B 1d; and,

BE IT FINALLY RESOLVED that, pursuant to Article III - Members, Section B 1(b) of the NCAI Constitution and By-Laws, the Delaware Tribe of Indians designates the following persons as Delegate and Alternate Delegate(s) and instructs them to become Individual Members in Good Standing with NCAI in order to fulfill their responsibilities as Official Delegates and Alternate Delegates to the National Congress of Americans Indians Annual Convention, Executive Council Winter Session and Mid-Year Conference.
