

## A RESOLUTION OF THE TRIBAL COUNCIL OF THE DELAWARE TRIBE OF INDIANS TO APPLY TO THE COORDINATED TRIBAL ASSISTANCE SOLICITATION GRANT FROM THE U.S. DEPARTMENT OF JUSTICE TO FINANCE ONE GRANT CONTAINING SEVEN OPPORTUNITIES INCLUDING TRIBAL JUSTICE, PUBLIC SAFETY, AND VICTIMIZATION ISSUES.

## **RESOLUTION 2023-22**

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

WHEREAS, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

**WHEREAS,** the Department of Justice is accepting applications for the Coordinated Tribal Assistance Solicitation; and

WHEREAS, the Delaware Tribe of Indians desires to participate in this grant program to the greatest extent possible as a means of expanding and adding services that include tribal justice, public safety, and victimization issues; and

WHEREAS, the Security, Court, and Family and Children Services Departments have identified areas of additional support and services needed within those departments as a high priority need; and

WHEREAS, the Coordinated Tribal Assistance Solicitation Grant will provide funding to improve public safety and victim services in the Delaware Tribal communities. There is one application with seven purpose areas including: Public Safety and Community Policing (COPS Office); Comprehensive Tribal Justice Systems Strategic Planning (BJA, COPS Office, OJJDP, OVC); Tribal Justice Systems Program (BJA); Tribal Justice System Infrastructure Program (BJA); Children's Justice Act Partnerships for Indian Communities (OVC); Juvenile Tribal Healing to Wellness Courts (OJJDP); Tribal Youth Program (OJJDP).

NOW, THEREFORE, BE IT RESOLVED, The Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve the application submission for the DOJ Coordinated Tribal Assistance Solicitation, the maximum funding amount of, \$4,000,000 (tribal budget to be determined) from the U.S. Department of Justice and designates the Executive Director of Tribal Operations as the Authorizing Official to sign all documents relating to the DOJ Coordinated Tribal Assistance Solicitation.
