WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and,

WHEREAS, on July 26, 2023, the Delaware Tribal Council approved and enacted Resolution 2023-76 titled, "A Resolution of the Tribal Council of the Delaware Tribe of Indians Amending the Delaware Tribe of Indians Secured Transactions Act," (the "Act") which referenced, among other things, approval of a Uniform Fee Schedule to be attached as Exhibit "A"; and

WHEREAS, due to a clerical error, the Uniform Fee Schedule as Exhibit "A" was inadvertently omitted from Resolution 2023-76; and

WHEREAS, the Delaware Tribal Council hereby corrects Resolution 2023-76 by including the Uniform Fee Schedule as Exhibit "A" to this Resolution; and

WHEREAS, the Delaware Tribal Council also hereby clarifies that any fees due and payable under Section 9-501(e) Act since the adoption of Resolution 2023-76 should be in accordance with the Uniform Fee Schedule attached to this Resolution as Exhibit "A."

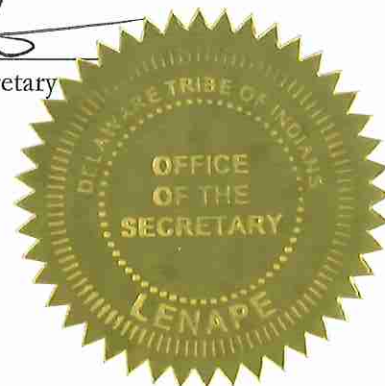
