SUBMIT A TRIBAL EARLY HEAD START
CONTINUATION GRANT FOR 2025**

RESOLUTION 2024-62

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and,

WHEREAS, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

WHEREAS, the Delaware Tribal Council of the Delaware Tribe of Indians adopts this resolution to authorize the submission of the continuation grant application and annual budget to the Office of Head Start for a Tribal Early Head Start to be located at 5106 Tuxedo Blvd, Bartlesville Oklahoma; and

WHEREAS, the Lenape Early Learning Center in accordance to Early Head Start Programing policies will provide child care services to low income and at risk tribal children and families as well as providing health screenings, developmental assessments, community/family engagement activities and offer support to the families it serves; and

WHEREAS, the Tribal Council of the Delaware Tribe of Indians has determined based off of the 2022-2027 Community Needs Assessment of the Tribal service region that it is in the best interest of the tribal community and herby approves the submission of the Tribal Early Head Start.

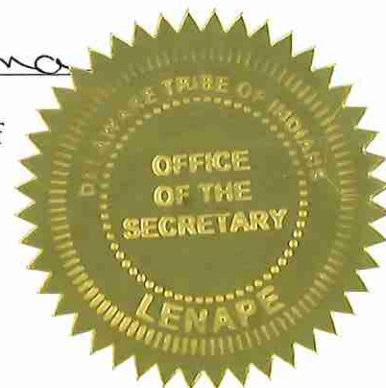
