

A RESOLUTION OF THE TRIBAL COUNCIL OF THE DELAWARE TRIBE OF INDIANS TO APPROVE THE PURCHASE OF MAINTENANCE AND GROUNDSKEEPING EQUIPMENT WITH THE COVID-19 ARPA REVENUE REPLACEMENT FUNDING

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

WHEREAS, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

WHEREAS, the Delaware Tribe was allocated funding from the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) from the U.S. Department of the Treasury established under the American Rescue Plan Act (ARPA) for the purpose of funding projects to safeguard and enhance the overall wellbeing of Delaware tribal members and applicable employee operations; and

WHEREAS, the Tribal Maintenance department expresses a need to replace and upgrade deteriorated equipment, as the current outdated machinery has led to operational delays and presents a significant safety hazard; and

WHEREAS, the upgraded equipment will allow the Tribal Maintenance department to perform routine duties and maintenance throughout the tribal campus, ensuring the tribal campus is safe for tribal employees and visitors; and

WHEREAS, this purchase is allowable under the ARPA Revenue Replacement guidelines as this investment will ensure the tribal campus is maintained, clear of debris or other hazards, and an overall safe environment for tribal employees to perform tribal services and operations; and

WHEREAS, the Delaware Tribal Council of the Delaware Tribe of Indians adopts this resolution to approve the purchase of maintenance and groundskeeping equipment with the COVID-19 ARPA Revenue Replacement funding.

NOW, THEREFORE, BE IT RESOLVED, The Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve the purchase of maintenance and groundskeeping equipment with the COVID-19 ARPA Revenue Replacement funding.
