



**A RESOLUTION OF THE TRIBAL COUNCIL
OF THE DELAWARE TRIBE OF INDIANS TO
PLACE THE DELAWARE TRIBE OF INDIANS
IN MEMBERSHIP WITH THE INTERTRIBAL
AGRICULTURE COUNCIL**

RESOLUTION 2025-05

WHEREAS, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

WHEREAS, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

WHEREAS, the Delaware Tribe of Indians is a Federally Recognized Indian Tribe and is recognized by the Secretary of the Interior of the list of federally recognized Indian Tribes, under 25 U.S.C sec 479; and

WHEREAS, the Intertribal Agriculture Council is a national, Native-led nonprofit that was formed in 1987 by order of Congress and tasked with pursuing and promoting the conservation, development, and use of agriculture resources for the betterment of Indian Tribes and Tribal agriculture producers; and

WHEREAS, since its formation, the Intertribal Agriculture Council has actively supported Native American and Alaskan Native Tribes and individuals across the country through on-the-ground technical assistance and services, and advocacy for improvements in federal and tribal policies that govern the agricultural landscape in which Native American and Alaskan Native Tribes and individuals must operate; and

WHEREAS, the priorities of the Intertribal Agriculture Council are set forth by member Tribes during the General Meeting in December of each year; and

WHEREAS, it is essential to the agricultural development of the Delaware Tribe's land base that the Delaware Tribe of Indians proceed with membership of the Intertribal Agriculture Council to join with other member Tribes in guiding the organization's annual priorities.

NOW, THEREFORE, BE IT RESOLVED, The Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve membership in the Intertribal Agriculture Council, and thereby approves payment of the membership fees in the amount of \$200.00, which shall thereafter be paid annually before November 15 of each year.

BE IF FURTHER RESOLVED, that the Delaware Tribal Council hereby authorizes the Chief to sign the Tribal Delegate Designation letter for the Intertribal Agricultural Council.
