



**A RESOLUTION OF THE TRIBAL COUNCIL  
OF THE DELAWARE TRIBE OF INDIANS TO  
CHANGE THE DESIGNATION ON A HOUSE  
FROM HOME OWNERSHIP TO LOW RENT**

**RESOLUTION 2026-02**

**WHEREAS**, pursuant to the Constitution and By-Laws of the Delaware Tribe of Indians, the Tribe's governing body is the Delaware Tribal Council; and

**WHEREAS**, the Delaware Tribal Council is authorized by Article V of the Constitution and Bylaws of the Delaware Tribe of Indians to represent and act in all matters that concern the general welfare of the Tribe; and

**WHEREAS**, the Delaware Tribal Council of the Delaware Tribe of Indians adopted Resolution 2022-78 on November 19, 2022, to change the designations on two houses, one from home ownership to low rent and one from low rent to home ownership; and

**WHEREAS**, the house located at 613 N.E. Cummings, Bartlesville, OK was at the time designated as Home Ownership and was changed to Low Rent following HUD guidelines with the passage of resolution 2022-78; and

**WHEREAS**, the house located at 213 Mistletoe Lane, Bartlesville, OK was not allowed by HUD guidelines to be converted from Low Rent to Home Ownership, but was erroneously included in the resolution, creating a need for correction; and


**WHEREAS**, the Delaware Tribal Council will rescind resolution 2022-78 which will fix the discrepancy for the home located at 213 Mistletoe Lane, Bartlesville, OK by returning it to its original designation of Low Rent; and


**WHEREAS**, the Delaware Tribal Council wishes to keep the designation of Low Rent for the house located at 613 N.E. Cummings, Bartlesville, OK as it was originally designated on November 19, 2022, following HUD guidelines and the passage of 2022-78.

**NOW, THEREFORE, BE IT RESOLVED**, the Delaware Tribal Council of the Delaware Tribe of Indians does hereby authorize and approve this resolution to keep the November 19, 2022 designation change to Low Rent for the house at 613 N.E. Cummings, Bartlesville, OK to continue serving the current needs of the housing participants.
