## Domestic

- ◆ *You do not own a foreign corporation*
- ◆ *No 953(d) election*
- ◆ *No BE-10 benchmark survey*

## Electronic

- ◆ *Applications can be completed electronically or via secure online portal*
- ◆ *Documents provided through secure portal*
- ◆ *Three business day turnaround*

## Direct Access

- ◆ *Easy, direct access to regulators and administrators*
- ◆ *Response in less than 24 hours*

## Affordable

- ◆ *One all inclusive fee*
- ◆ *No initial jurisdiction fees for domesticating an existing company*
- ◆ *No separate fees to verify good standing, name reservation requests, or other service requests*

The “Treaty with the Delawares” was signed on September 17, 1778. Under the treaty, the United States recognized the Delaware Nation’s sovereignty. The 2013 U.S. Mint Native American dollar coin commemorates this treaty.

## Why choose The Tribal Domicile

- ◆ **The Tribal Domicile** is a reinsurance domicile primarily focused on ARCs.
- ◆ **The Tribal Domicile** regulators will take your call; there are no middlemen.
- ◆ **The Tribal Domicile** has an “all in” annual fee. There are no separate fees to verify a company’s good standing or to change its line of business.
- ◆ **The Tribal Domicile** is committed to fast turnaround, with most formations or domestications being completed within three business days.
- ◆ **The Tribal Domicile** has formation, renewal, and domestication forms that can be completed and submitted electronically.
- ◆ **The Tribal Domicile** does not charge jurisdiction fees for domestication of existing companies in the first year.
- ◆ **The Tribal Domicile** listens to the industry, with laws and regulations based on U.S. laws and regulations, written in plain language.
- ◆ **The Tribal Domicile** is growing, with over 1,000 companies formed or domesticated since inception.

## The legal support behind The Tribal Domicile

U.S legal pronouncements establish the power of The Tribal Domicile to be an Insurance Domicile:

- ◆ The U.S. Constitution recognizes Indian Tribes as separate from the federal government, the states, and foreign nations.
- ◆ An 1828 Supreme Court decision identified an Indian Tribe as a domestic, dependent, sovereign nation.
- ◆ The power to regulate commerce is an established power of a sovereign government.
- ◆ The Tribe’s power to regulate its commerce is derived from tribal sovereignty.
- ◆ A Tribe has all powers of a sovereign nation unless a U.S. treaty or federal statute removes a power.
- ◆ IRS regulations specifically list a Tribal corporation as a domestic corporation.
