### Call to Order

The meeting was called to order by Chief KillsCrow at 6:00 p.m.

**Motion-To Suspend the Rules.** Assistant Chief Anna made a motion to suspend the rules and amend the agenda to add appointment of the new Tribal Council member to the next item of business, then item L.
